Work shall be coordinated with the General Contractor in accordance with the then-current building construction schedule and Vendor shall complete the work by the targeted dates by floor. All AV equipment must be installed and all wiring completed for approval by electrical inspection to receive Beneficial Occupancy.

A copy of the building construction schedule that is current as of the Issue Date of this RFP is included in the Design Documentation."

B. Specification Section 274010 (Audio-Visual General), Part 1 (General), Paragraph 1.8 (Information to be Submitted with the Bid Return), Subparagraph D (Bidder Information), Section 2 (Project References) of the Design Documentation is revised and restated as follows:

"Project references – provide three (3) reference projects of similar university classroom buildings completed in the last **five (5) years** where the overall contract award was at least \$3,000,000 (three million dollars). References must include:"



- E. On AV-201C (Infrastructure Drawing Set), the ceiling type in Prefunction 1002 has changed to a wood slat type ceiling.


Provide and install one (1) subwoofer and four (4) pendant speakers to match those indicated on the Bell Building Equipment Worksheet for System Type 6. These replace the speakers previously shown in this area. Reference the images below.



- F. The ceiling microphone in System Type 13 shall be provided with a custom color by the manufacturer. The color will be confirmed by the University during the submittal process.
- G. For System Type 15, provide and install two (2) AM-3200WF wireless presentation units, one (1) per display. This is in lieu of the HDMI connection to the floor box.
