- 1. **Question**: Is the university open to substitutions specifically for the Crestron components? We would provide substitutions that would meet or exceed the requirements of the university.

Answer: Substitutions to another manufacturer for Crestron equipment are not permitted.

However, for any device specified as Crestron on the Bell Building Equipment Worksheet, if there is a *newer* Crestron device that provides equal or greater functionality, consideration would be given to that product.

The Bell Building Equipment Worksheet indicates for each item whether alternates will be accepted for consideration.

2. **Question**: The Specification document 274010 noted in letter f seems to be missing. Can this document be provided, or should that section be ignored? (Reference Section 8.3.2 (Offer Organization) of the RFP)

3. **Question**: The due date of the vendor proposals shows as March 20th in the RFP but the included schedule shows the selected vendor starting AV rough in on some areas as early as March 3rd with the RFP document noting start of cable pulling in March 2025. Could you please clarify that the AV vendor would not be held to the current dates shown on the included schedule beyond the required completion date, as several of the AV dates would be prior to contract award? (Reference Section 2.1 (Introduction) of the RFP, and the Design Documentation)

Answer: Vendor must develop their own installation schedule for the specific tasks/milestones in the scope in concert with the building construction schedule to meet the completion deadline. Any applicable installation or construction schedule-related dates listed in the RFP or Design Documentation that are prior to the Effective Date of any contract awarded pursuant to this RFP will be revised accordingly.
