- How much detailed programming for the campus has already been developed for use at the start of the master plan?
 - WTCC has identified programming, and a general description (located in the included project description) of programming that will be created/transfer from existing campuses.
- Does WTCC Anticipate any contractor assistance for phasing or cost analysis during masterplan?
 - Please refer to Section II, Page 2, B. #4.
- Is there any additional site boundary information available that clarifies the campus location within the larger development.
 - Please see included draft rendering for potential concept/campus location.



- Can the requirement for licensure in NC be fulfilled after successful completion of the RFQ process?
 - A current licensure in NC will be required for this submission.
