Questions must be submitted by close of business (5pm) on Wednesday, August 7, 2024.

- c. Sealed bids must be submitted by 10:00 AM on Thursday, August 15th, 2024 to the Town of Cary at the office of the Utilities Department, Conference Room 21275, 2nd floor of Cary Town Hall, 316 North Academy Street, Cary, North Carolina, at which time they will be opened and read publicly.
- d. The project has a schedule of 101 consecutive calendar days to substantial completion and 131 days to final completion. Intermediate Contract Times as follows:
 - o ICT#1: 45 consecutive calendar days allowed for pre-construction
 - ICT#2: 56 consecutive calendar days allowed for construction. Date of availability for this intermediate contract time is as directed by Town of Cary.
 - Start date for ICT#2 to be as directed by the Town, currently anticipated to be February 1, 2025.

Liquidated Damages in the amount of \$1,200 per day are included in the contract.

 - a. Install approximately 1,100 LF of 12-inch DIP Water Main
 - b. Abandon approx. 1,140 LF of existing water main and appurtenances
 - c. Approx. four (4) 1-inch water service connections
 - d. Erosion control, traffic control, surface restoration, and all associated appurtenances
 - e. Project will involve schedule coordination with other contractors and Town departments.
- 7. Kimley-Horn will provide a Resident Project Representative to observe construction.
- 8. No Addenda issued to date. Addendum #1 will be issued after the pre-bid meeting.
- 9. Permits
 - a. Town of Cary Water Extension Permit Approved
- 10. Owner Procured Materials
 - a. Materials and quantities to be provided by the Town of Cary are identified in Section 00250 "Instructions to Bidders."
 - b. Contractor is responsible for loading and transporting materials from the Cary laydown yard at 313 N. Dixon Avenue, Cary, NC 27513.
 - c. Contractor must complete affidavit provided in Specification Section 00800 following visual inspection of materials and upon taking ownership of Town procured materials.
- 11. Project-Specific Comments
 - a. Water service interruptions must be between 9 a.m. and 4 p.m. with a 4-hour maximum time frame per interruption. Outages to water service will only be allowed Tuesday through Thursday and with advance notice to Town of Cary Utilities Department and affected customers.
 - b. Trenches must be backfilled and road opened to traffic at the end of each work day. Contractor shall patch roadway pavement disturbances by the end of each week.
 - Contractor can provide temporary asphalt patch to pavement disturbances, with the full depth trench restoration taking place at the end.

c. Work Hour Restrictions

Do not close or narrow travel lanes as follows:

- o Kildaire Farm Rd
 - STA 9+90 to STA 10+00 5am 9pm Mon-Fri
 - Involves outage of water service for Cary Elementary School - Will require weekend or nightwork.
 - STA 10+00 STA 12+50 6am 9am Mon-Fri
 - Hours restricted for traffic control in the turn lane into Cary Elementary school.
