Renovation of 1,379 sq. ft. to create office space for the HR Dept.

Alterations include creation of storage space, conference room, and three new office spaces; materials and finishes include but are not limited to steel stud and gypsum drywall partitions, carpet, vinyl wall base, doors and door hardware, suspended acoustic tile ceilings and suspension systems, painting, LED lighting fixtures, and relocating/rerouting existing duct configurations for the new floor layout.
