In accordance with the provisions of G.S. 133-3, material, product, or equipment substitutions proposed by the bidders to those specified herein can only be considered during the bidding phase until five (5) days prior to the receipt of bids or by the date specified in the pre bid conference, when submitted to the Designer with sufficient data to confirm material, product, or equipment equality. Proposed substitutions submitted after this time will be considered only as potential change order
- 5. Notice to Proceed anticipated for Monday, January 29, 2024.
- 6. Number of Contract Consecutive Calendar Days: 99
- 7. Final Closeout anticipated, Tuesday, May 07, 2024.

D. Form of Proposal

- 1. All applicable Federal, State and Local Taxes shall be included in the Bidder's Proposal.
- 2. Review all Alternates, Allowances, and Unit Prices in the Project Manual. Provide cost for each Unit Price and Alternate as listed on the Form of Proposal. Allowance amounts shall be factored into the Base Bid cost.

- E. Minority Business Enterprises (MBE) Requirements

 complete documentation within 72 hours of notification.
 - (b) Affidavit B Intent to Self-Perform (only if the intent is to hire no subcontractors).
 - (c) Failure to include these documents with the bid is grounds for rejection of the Bid.
 - 3. List all plumbing, mechanical, and electrical subs, as indicated on the Bid Form. List the total dollar amount of participation. List \$0 if none. "TBD" is considered incomplete.
- F. Qualification and Award of Contract
 - 1. Bidders must hold proper North Carolina General Contractors License.
 - 2. Contract will be awarded to the lowest responsive and responsible bidder.
 - (a) Responsive = a complete Form of Proposal and conformance to Bidding Requirements.
 - (b) Responsible = capable to perform all requirements, meet schedule, quality of performance on previous jobs.
- G. Prior to Award of Contract, the Owner may request that the successful low bidder:
 - 1. Submit a Statement of Work to be performed by his own forces.
 - 2. Demonstrate capable labor force and experience required to coordinate and perform the Work.
 - 3. Submit record in performance of any contracts with the City of Raleigh or similar entities.

- H. Upon Notice of Award, the successful bidder must submit:
 - 1. Liability Insurance, Property Insurance / Builder's Risk and Worker's Compensation.
 - 2. Performance and Payment Bonds are required for this project.
- I. Scope of Work Refer to complete drawing and specifications for detailed scope of work.
 - 1. New flooring and base throughout the facility, interior painting, casework modifications in multi-purpose rooms and kitchen alteration including new casework and appliances.
 - 2. Minor electrical, plumbing and mechanical changes as indicated on the drawings.
- J. Carefully examine conditions
