The City of Asheville requires the assistance of a contractor to replace the existing Bell & Gossett VSC 10X10X13; Identification Number 685703 AN; Model 12-1/4 BF, L.H.R.; 2200 GPM; 150 FT Lift;Maximum working pressure 175 PSI; 125 HP; 1750 RPM pump assembly with a BEII & Gossett VSX-8X10X17.5 Bell & Gossett VSX-8X10X17.5 Bell & Gossett Vertical Split Case Pump Series VSX-VSC, Model 8 X10 X 17-1/2, BF, 125 HP, 1800 RPM, 2200 GPM, 150 FT pump assembly or a pump assembly equal or greater than pump listed. To replace the triple duty valve and set the water flow specific to the McQuay chiller, Model L-E3616RE2RA, Style 066330901E, Serial No. 58B0000600. To provide all the necessary piping, fitting, valves, insulation and any miscellaneous parts to complete the project. The start date for repairs is as soon as possible.
