The following changes to this bid documents are to be incorporated as part of this addendum:

#### Questions received in advance of the deadline for written questions - April 23, 2025:

- Can drawings or renderings of the pickleball courts be provided?
   RESPONSE: Yes. Proposed Site Plans are included in the project manual, which can
  be downloaded from the Electronic Vendor Portal. Please refer to Appendix II (pages
  74–75) for the relevant drawings.
- 2. Is a Performance and Payment Bond required? RESPONSE: A Performance & Payment Bond is not expected to be required unless the total bid amount approaches the \$300,000 threshold.
- Since this is not a public bid opening, should bid packages be dropped off at 222 West Hargett St.?
   RESPONSE: No hard copy submission is required. Please follow the electronic bidding submission instructions outlined in the Proposal Form.
- 4. Will the project require any asphalt paving work? RESPONSE: Extensive asphalt repaving is not required at either site. However, associated asphalt-related improvements may include, but are not limited to: removal of existing tennis posts, installation of new pickleball posts, and localized repairs to depressions, holes, and surface cracks.
- 5. Is SportMaster an approved vendor or product for patch work and resurfacing on this project? RESPONSE: SportMaster is an acceptable manufacturer; however, all products used for this project must comply with the requirements outlined in the project specifications.

#### Questions received during the pre-bid meeting held on April 16, 2025:

1. Is there any flexibility on the five-year warranty?
RESPONSE: Yes. In place of a five (5)-year warranty, the Contractor shall warrant the work for a period of one (1) year following final acceptance. During this period, the

Contractor is responsible for correcting any defects resulting from faulty workmanship or materials.

- Is the 5% bid security mandatory?
   RESPONSE: No. Bid security is not required for projects with an estimated cost under \$500,000.
- 3. What is the funding source for the project? RESPONSE: The project is funded through City of Raleigh Capital Funds.

#### Introduction

The purpose of this meeting is to review project scope and bidding requirements regarding the **Pickleball Court Conversion** site improvements project.

Nothing during this meeting, as far as clarifications and/or answers, are to be taken as official responses. Bidders are requested to submit questions via email as indicated below. Final responses will be covered in addenda. Addenda will serve as official clarifications and answers to bidders' questions. Official meeting minutes will be issued as an addendum.

This project is being bid as an Informal Bid Project and as a Single Prime Contract. All contractors must have a valid General Contractors license in state of North Carolina.

#### **Project Scope**

Refer to drawings and project manual for complete description of project scope. The project includes:

- Sanderford Road Park: Permanent conversion of three (3) existing tennis courts into dedicated pickleball courts.
- Carolina Pines Park: Permanent conversion of two (2) of the three (3) existing tennis courts into dedicated pickleball courts.
- Associate site improvements include but not limited to:
  - Site preparation
  - Surface modification
  - Line striping
  - Fence installation
  - Net installation

- Gate installation and creation of access openings
- The Bidder represents and agrees to complete the entire project in the following number of Consecutive Calendar Days: Seventy (70) days from the date on the Notice to Proceed (NTP).
