Question 1: Are there current structural and electrical drawings for the facility?

Question 3: What are the weight limitations of the existing hoist system?

Question 4: Is there an estimate/budget amount that is able to be released for this project?

Question 5: Is there a projected (or even just desired) NTP/Completion date the school would like the work to be completed?

Question 6: In the bid, it mentioned to reach out to you for access to as built drawings of the building. Could you please advise as to the best way to receive those drawings as we review the project?

Question 7: What is the weight capacity of center hoist?

Question 8: Can you provide exact measurements of the current video boards?

Answer: We do not have the exact measures although we did find a document that stated we have two (2) Daktronics ProStar Video Displays that are 800 x 640, 16 mm and approximately, 9' h x 12' w. Contractor should field verify existing dimensions.

Question 9: Assumptions of ample power supplied for center-hung videos (Can you provide power supply at the video)?

Question 10: Assumptions that current data runs are sufficient for operation of the scorer's tables?

Answer: The current data runs are sufficient with present equipment, new equipment should work without issue.

Question 11: Are current data runs operational?

Answer: Yes, current data runs are operational.

Question 12: Will a conduit pathway be provided for fiber or data cable runs?

Answer: Any new fiber or data runs shall be by the Contractor who is awarded the project, including cable management (conduit).

Question 13: It looks like you are listing (2) 20' LED Video scorer's tables which will be (4) 10' LED Tables and you are also listing (4) 10' Backlit Scorer's tables. Are you wanting both LED Video and Backlit tables?

Answer: We want quotes for both. However, the (4) 10' Backlit Scorer's tables can be an alternate depending on overall price quotes. Contractor should field verify existing dimensions.

Question 14: For the new standard boards with the Electronic team names, do you want the ability to change the sections?

Answer: Ability to change names if possible at no additional cost.

Question 15: Can you confirm that we are to reuse the existing cabling to each scoring location IF new cable is needed, can we assume that scope of work is covered by the University?

Answer: Any required new electrical, fiber, or data runs shall be by the Contractor who is awarded the project, including cable management (conduit).

Question 16: At the site walkthrough, it was said that the fixed digit scoreboards would be replacing the existing corner wall mounted video displays. Is this still the location for install and if so, do you have the dimensions of the existing screens to determine how they will fit in that area and if trim is needed?

Answer: We do not have the exact measures although I did find a document that stated we have two (2) Daktronics ProStar Video Displays that are 160 x 208, 16 mm and approximately, 9' h x 12' w. Contractor should field verify existing dimensions.

Question 17: Are we to use the Daktronics specs sent in Addendum 1 as the new equipment specs?

Answer: Yes, if possible please use the Daktronics specs, however, if you have a different product that meets the same needs we are open to considering that in our review.

Question 18: Can you confirm that any decorative signage on the center-hung is non illuminated?

Answer: The corner shrouds are non-lit.

Question 19: Can you confirm the desired timeframe for completion?

Answer: Before August 1, 2025.

Question 20: The bid calls out minimum of 6' x 11' video displays but the addendum says screens no bigger than 9'x12'. Is there a size for vendors to try meet so that we bid apples to apples with vendors?

Answer: We do not have the exact measures although I did find a document that stated we have two (2) Daktronics ProStar Video Displays that are 800 x 640, 16 mm and approximately, 9' h x 12' w. Contractor should field verify existing dimensions.
