General Notice

Cumberland County (Owner) is requesting Bids for the construction of the following Project:

Test Well Program – Gray's Creek Phase I

Bids for the construction of the Project will be received at 130 Gillespie St. Fayetteville, North Carolina 28301 in Room 214, until Monday March 11, 2024, at 9:00 am local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Installation, development, and testing of three test wells for the purpose of assessing the quantity and quality of water from the Black Creek aquifer at locations on Chicken Foot Road in Cumberland County, North Carolina. Elements of the project include the following at each of the three locations:

- Identification of underground utilities
- Clearing and grubbing
- Installation of erosion control measures
- Geophysical logging of borehole
- Installation of 6-inch diameter test well to a depth of approximately 180 feet
- Development of test well
- Aquifer testing
- Coordination of water sampling
- Laboratory analyses of water samples
- Surface completion or well abandonment
- Surface restoration

Bids are requested for the following Contract: Test Well Program – Gray's Creek Phase I

The Project has an expected duration of 90 days to substantial completion and 180 days to final completion.
