Bids will be opened and read publicly in Conference Room 11130, 1st floor, 316 North Academy Street, Cary, for the furnishing of materials, labor, and equipment for the construction of Higgins Greenway, Project No. PR1267. Approximate quantities involved are as follows:

Higgins Greenway Phase III includes +/- 4,550 LF of new greenway, which varies in width between 6ft and 12ft. The Greenway Extension includes six (6) cast-in-place retaining walls, decorative brick columns, gates, and fencing in the Hillcrest Cemetery, and two trail heads with information kiosk and stamped concrete paving. Ornamental landscaping will be installed along certain portions and the remaining areas of disturbance will be stabilized with permanent groundcover seeding.

Contractors offering a proposal on this project must comply, and must ensure that their subcontractors comply, with the requirements of Article 2 of Chapter 64 of the North Carolina General Statutes, "Verification of Work Authorization," and must provide documentation or sign affidavits or any other documents requested by the Town of Cary demonstrating such compliance.

Each proposal shall be accompanied by a bid deposit in the amount of not less than five percent (5%) of the amount of the bid in the form and subject to the conditions provided in the Instruction to Bidders.
