

3. Mail in Bid packages will be accepted until close of business March 19th, 2025, and held until the public bid opening on March 20th, 2025. Mail in bid packages can be mailed to 2550 Operations Way, Raleigh, NC 27604. Mailed bids are recommended to be delivered with a signature confirmation or certified mailed service.

SECTION 00200 INSTRUCTIONS TO BIDDERS

1. Under Article 15 - Submittal of Bid Section 15.03 DELETE and REPLACE with "A Bid shall be submitted no later than the date and time prescribed and at the place indicated in the Advertisement For Bids and shall be enclosed in a plainly marked package with the Project title, City Bid Number, and project name as applicable, the name and address of Bidder, and shall be accompanied by the Bid security in an separately sealed envelope, marked as such, and attached to the Bid envelope and other required documents. If a Bid is sent by mail or other delivery system, the sealed envelope containing the Bid shall be enclosed in a separate package plainly marked on the outside with the notation "BID ENCLOSED." A mailed Bid shall be addressed to Claudia White, City of Raleigh, Engineering Services Department, Stormwater Service Unit 2550 Operations Way, Raleigh, NC 27604. Sealed Bids will be received until 2:00PM, Thursday 3/20/2025, at 2550 Operations Way, Room 208, Raleigh, NC 27604, at which time and place bids will be publicly opened and read aloud for the construction of the Stormwater Rehabilitation project.

Mail in Bid packages will be accepted until 5:00PM, Wednesday, March 19th, 2025, and held until the public bid opening on Thursday, March 20th, 2025. Mail in bid packages can be mailed to 2550 Operations Way, Raleigh, NC 27604. Mailed bids are recommended to be delivered with a signature confirmation or certified mailed service that can verify time of delivery and receipt of Bid package.

After Bids are opened, the Owner shall evaluate them in accordance with the methods and criteria set forth in the Instructions to Bidders. The Owner/City Council reserves the right to waive any informality or to reject any or all Bids. Unless all Bids are rejected, Award will be made to the lowest responsible and responsive Bidder, taking into consideration quality, performance and the time specified in the Bid Form for the performance of the Contract.

Bidders must have attended the Mandatory Pre-Bid Meeting that was held on Tuesday, January 28th, 2025, at 2550 Operations Way, Room 232, Raleigh, NC 27604.

Requirements for pre-bid submittals of an "or-equal" are required within 10 days of the issuance of the Advertisement for Bids and in accordance with Section 00200, Instructions to Bidders.

The Project consists generally of the following major items:

Rehabilitation of approximately 3,425 linear feet of stormwater pipes with UV GRP CIPP Lining, cementitious coating and concrete repairs, drainage structure installation, concrete top installation, curb and gutter installation, traffic control.

Bidding Documents may be viewed and ordered online by registering with Duncan Parnell via their bid room <https://bidroom.duncan-parnell.com/>. Registration with Duncan Parnell is required to obtain the bid documents and be added to the official Plan Holder's List. Addenda will only be notified to those buying full sets from Duncan Parnell via their bid room. The cost of bid documents and shipping is non-refundable. OWNER/ARCHITECT/ENGINEER will NOT be responsible for copies of the bid documents obtained from sources other than from Duncan Parnell. With each request for Bidding Documents supply the following information: Company name, contact person, street address, phone number, and email address for Bidding point of contact; N.

C. contractor's license with limitation and classification; indicate if the firm will be a Prime bidder, Supplier or Sub-Contractor.

Bidders will be required to show evidence that they are licensed to perform the work in the Bidding Documents as required by North Carolina General Statute, Chapter 87 and the Instruction to Bidders.

Bid Security in the amount of five percent (5%) of the Bid must accompany each Bid and shall be subject to the conditions provided in the Instruction to Bidders.

Pursuant to General Statutes of North Carolina Sections 143-128.2 and 143-131, and in accordance with City policy, the City of Raleigh encourages and provides equal opportunity for certified Minority and Woman-Owned Business Enterprise (MWBE) businesses to participate in all aspects of the City's contracting and procurement programs to include Professional Services; Goods and Other Services; and Construction. The prime contractor will be required to identify participation of MWBE businesses in their Bid, and how that participation will be achieved.

Furthermore, the City's goal is to contract or sub-contract fifteen percent (15%) of the contract amount to certified MWBEs on construction projects over \$300,000, or with contracts that include \$100,000 or more in state funding.
