### 1.0 PURPOSE AND BACKGROUND

Western Carolina University (WCU), a member institution of the University of North Carolina System, is seeking qualified vendors to supply a complete overhaul of our WCU television studio and teaching space located within the John W. Bardo Fine and Performing Arts Center.

Currently, our studio is set up so that there is a large studio room, a control room that doubles as a classroom, two editing bays, an equipment closet, a terminal equipment room (rack room), and an office.

The facility was designed in the early 2000s with much of the gear being original to the studio when it was constructed in 2004. There was a moderate upgrade to the studio in 2017 where the studio was upgraded to HD and we bought new cameras, a new production switcher and several other items. Unfortunately, during this upgrade process most of the old equipment and cable was not removed so we currently have thousands of feet of unused cable under the floor and unused equipment in our racks.

The intent of this solicitation is to award an agency specific contract.

Proposals shall be submitted in accordance with the terms and conditions of this RFP and any addenda issued hereto.

### 1.1 CONTRACT TERM

Any contract resulting from this RFP will be a one-time equipment purchase and installation with recurring maintenance agreements for years 2-4. This maintenance agreement will be purchased on a yearly basis with the option by Western Carolina University to extend or cancel prior to the upcoming year. A sixty (60) day notice will be submitted prior to upcoming year with WCU's decision to extend or cancel.

### 2.0 GENERAL INFORMATION

Vendors submitting responses to this RFP should do so by following instructions listed in section "4.0 Requirements".

### 2.1 REQUEST FOR PROPOSAL DOCUMENT

### 2.10 DEFINITIONS, ACRONYMS, AND ABBREVIATIONS

Relevant definitions for this RFP are provided in 01 NCAC 05A .0112 and in the Instructions to Vendors found below which are incorporated herein by this reference.

### 3.0 METHOD OF AWARD AND PROPOSAL EVALUATION PROCESS

### 3.1 METHOD OF AWARD

North Carolina G.S. 143-52 provides a general list of criteria the State shall use to award contracts, as supplemented by the additional criteria herein. The Goods or Services being procured shall dictate the application and order of criteria; however, all award decisions shall be in the State's best interest. All qualified proposals will be evaluated, and awards will be made to the Vendor(s) meeting the specific RFP Specifications and achieving the highest and best final evaluation, based on the criteria described below.

While the intent of this RFP is to award a Contract(s) to a single Vendor for all line items, the State reserves the right to make separate awards to different Vendors for one or more line items, to not award one or more line items or to cancel this RFP in its entirety without awarding a Contract, if it is considered to be most advantageous to the State to do so.

If a Vendor selected for award is determined by the State to be a non-resident of North Carolina, all responsive proposals will be reviewed to determine if any of them were submitted by a North Carolina resident Vendor who requested an opportunity to match the price of the winning proposal, pursuant to Executive Order #50 and G.S. 143-59 (for more information, please refer to ATTACHMENT H: VENDOR REQUEST FOR EXECUTIVE ORDER #50 PRICE MATCHING. If such proposals(s) are identified, the State will then determine whether any such proposal falls within the price-match range, and, if so, make a Contract award in accordance with the process that implements G.S. 143-59 and Executive Order #50.

The State reserves the right to waive any minor informality or technicality in proposals received.

#### 3.2 CONFIDENTIALITY AND PROHIBITED COMMUNICATIONS DURING EVALUATION

While this RFP is under evaluation, the responding Vendor, including any subcontractors and suppliers, is prohibited from engaging in conversations intended to influence the outcome of the evaluation. See the Paragraph 28 of the Instructions To Vendors entitled COMMUNICATONS BY VENDORS...

Each Vendor submitting a proposal to this RFP, including its employees, agents, subcontractors, suppliers, subsidiaries and affiliates, is prohibited from having any communications with any person inside or outside the using agency; issuing agency; other government agency office or body (including the purchaser named above, any department secretary, agency head, members of the General Assembly and Governor's office); or private entity, if the communication refers to the content of Vendor's proposal or qualifications, the content of another Vendor's proposal, another Vendor's qualifications or ability to perform a resulting contract, and/or the transmittal of any other communication of information that could be reasonably considered to have the effect of directly or indirectly influencing the evaluation of proposals, the award of a contract, or both.

Any Vendor not in compliance with this provision shall be disqualified from evaluation and award. A Vendor's proposal may be disqualified if its subcontractor and/or supplier engage in any of the foregoing communications during the time that the procurement is active (*i.e.*, the issuance date of the procurement until the date of contract award or cancellation of the procurement). Only those discussions, communications or transmittals of information authorized or initiated by the issuing agency for this RFP or inquiries directed to the purchaser named in this RFP regarding requirements of the RFP (prior to proposal submission) or the status of the award (after submission) are excepted from this provision.

#### 3.3 PROPOSAL EVALUATION PROCESS

Only responsive submissions will be evaluated.

#### The State will conduct a One-Step evaluation of Proposals:

Proposals will be received according to the method stated in the Proposal Submittal Section above.

All proposals must be received by the issuing agency not later than the date and time specified in the RFP SCHEDULE Section above, unless modified by Addendum. Vendors are cautioned that this is a request for offers, not an offer or request to contract, and the State reserves the unqualified right to reject any and all offers at any time if such rejection is deemed to be in the best interest of the State.

The tabulation shall be made public at the time it is created. When negotiations after receipt of bids is authorized pursuant to G.S. 143-49 and 01 NCAC 05B.0503, only the names of offerors and the Goods and Services offered shall be tabulated at the time of opening. If negotiation is anticipated, cost and price shall become available for public inspection at the time of the award. ### 5.0 PRODUCT SPECIFICATIONS AND SCOPE OF WORK

#### 5.1 GENERAL

Western Carolina University desires to upgrade the College of Arts and Sciences television studio and the School of Music's recording studio. Uniquely, the television and recording studio are located adjacent to one another in the Center for Applied Technology. The two facilities both share integrated terminal rack room space, analog and digital patch bays, and a routing switcher for program exchange. Likewise, there are existing conduits below removable panel "computer" flooring and above-the-ceiling cable trays for interconnection between the two studios. As an example, television studio cameras are often moved to the recording studio for live in studio concerts using camera connectivity on the existing breakout panels in the recording studio is a requirement.

#### 5.2 SPECIFICATIONS

The university desires a general overhaul of the television studio environment. A major component of the overhaul will include the removal of all decommissioned and unused equipment as determined by the university. This includes the removal of all audio and video cabling deemed unnecessary. The university retains the right to recycle or sell for scrap the unused cabling.

# System Integration and Installation

A complete system integration between proposed new and existing equipment is required as a part of the project. The scope of the work shall include the integration, installation, and necessary new equipment to interface with existing equipment. All audio, video, data, power and control cables are required to be clearly labeled and identified at each cable termination. During and upon completion of the integration and installation of equipment a proof of performance demonstration is required. Additionally, system training sessions are to be included for university staff.

### As-built Drawings and Documentation

At the conclusion of the integration and installation of all new and existing equipment a complete set of as-built drawings are required.

### WCU Television Studio Upgrade

- Cameras: The television studio has Sony HSC 100r broadcast cameras with Fujinon lenses. Although satisfied with the current Sony cameras, the studio staff requests upgrade options. The desire is to upgrade to UHD or 4K cameras. The current cameras use Triax cable. New cameras are to use SMPTE fiber-optic cables. There is interest in the Sony HDC-3100 camera. Staff would be open to equivalent or alternate suggestions.
- Video Switcher: A Ross Carbonite switcher is specified with 2 ME TouchDrive TD2S with touch screen control panel/display.
- Video router: A Ross Ultrix video router is specified.
- Graphics: The Ross Xpression system is specified.
- Intercom: The present intercom system is beyond its service life. An intercom system is required to communicate with the studio camera positions, floor manager, director station, technical director station, producer station, graphics station, video playback station, audio booth and engineering stations. Additionally, one intercom station is needed at the audio console in the recording studio control room.
- Audio: The television studio lacks a dedicated audio booth separate from the television control room. The present audio console is new and is to be moved from the television control room to the audio booth. The new audio booth is presently an unused video edit bay. In addition to desk workspace and console furniture, the booth will require stereo audio monitor speakers and a video monitor that can be fed a Multiview feed.
- Video Server: There is currently a Ross Abikas Tria in service. A newer version of the Tria or the Tria+ is specified.

• Studio Sets: The current television studio sets are beyond their service life and are dysfunctional. New design(s) are required to be versatile/flexible and suitable for newscasts, game shows, interviews, music productions.

### **Audio Recording Studio**

Upgrades to the television studio will result in necessary upgrades to the recording studio. These needs include integration of the routing switcher and audio feeds to and from the television and recording studio breakout panels.

### The Audio Control Room

The audio control room is the largest space for multitrack recording and mixing A new audio console must be able to accommodate 48 analog inputs. The console needs the ability to accept feeds from multiple rack mounted preamps through a patch bay. The analog console preamp inputs should be able to be routed to a digital converter for recording on a digital audio workstation. For example, ProTools or Logic Pro X.

Individual console channels require the ability to be monitored individually. There should also be a system/breakout panel to accommodate sending and receiving audio from outboard analog equipment.

Other functionality of the space is sending monitor signal to two different sets of stereo monitors, and one set of 5.1 surround sound speakers.

### Audio Edit Room #1

Audio edit rom # 1 needs to be Dolby Atmos compatible and will serve as a primary space for audio postproduction, music composition, and audio editing and mixing. The space will house an Avid S6 digital console to mix and monitor audio from.

### Audio Edit Room #2

Audio edit room # 2 will serve as a secondary mixing room with two sets of speakers for different monitoring options. The primary use of the space will be for audio editing, audio mixing, and mastering.

### **Overall Recording Studio Needs:**

The primary audio control room shall incorporate a Dante Network infrastructure so that audio can be received and sent from each computer in the three different spaces. The goal for the recording spaces would be to send and receive at least 16 channels of audio between the digital audio worksations.

### 6.2 POST AWARD PROJECT REVIEW MEETINGS


