**PROJECT: GOLDSBORO WATER TREATMENT PLANT INTAKE SCREEN REPLACEMENT PROJECT**

Sealed Bids for the construction of the indicated project will be received by the **City of Goldsboro**, at which time the Bids received will be publicly opened and read at that time and location. All Bids submitted shall include one original set of the Bid Documents.

The Work is located in **Goldsboro, North Carolina at the Water Treatment Plant Raw Water Intake Site near the intersection of Stevens Mill Road and Farm Road in Goldsboro, NC.**

The Work consists of the following:

- Replacement of one wedge-wire water supply intake screen (to be furnished by Owner).
- Pre-construction mussel survey with relocation of federally protected mussels, if found (see Appendix A – M&R #4 for requirements).
- Post-construction Neuse River Waterdog Survey (see Appendix A – M&R #5 for requirements).
- Dredging in the vicinity of the intake screen to facilitate screen removal and replacement of the screen.
- Hauling and disposal of the materials removed from the work area to an acceptable offsite disposal location.

Bids will be received for a **SINGLE** prime Contract. Bids shall be on a **LUMP SUM AND UNIT PRICE BASIS**, as indicated on the Bid Form. The Contract Times for the Work are set forth in the Agreement.

Following registration, complete sets of Bidding Documents may be downloaded from the Issuing Office's website as "zipped" portable document format (PDF) files. The cost of printing Bidding Documents and shipping is non-refundable. Payments shall be made to the Issuing Office.

Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. The Bidding Documents will include one full-size set of Drawings with a printed copy of the Project Manual. Partial sets of the Bidding Documents will not be available from the Issuing Office.

Each Bidder must be a Bidding Document Holder. Bids submitted by Bidders not on the list of Bidding Documents (Plan) Holders with the Issuing Office will not be opened.

A non-mandatory virtual pre-bid meeting will be held at 11:00 am, on Tuesday October 1, 2024 on Microsoft Teams to discuss the Project and answer pertinent questions. Attendance at the

pre-bid meeting and visit is encouraged. Contractors may coordinate with the City to schedule a site-visit at a later date if desired.

Bid security shall be furnished in accordance with the Instructions to Bidders.

Bidders shall submit proof of qualifications to perform the Work as described in the Instructions to Bidders.

The right is reserved to reject any or all bids, to add or delete work, to waive informalities, and to award contract which, in the opinion of the City, appears to be in its best interest.
