Pursuant to North Carolina General Statutes 143-131 Bids will be received by the City of Asheville for the following:

Description of Bid:

The City of Asheville is requesting the submission of qualified contractors to provide repair finishes and replacement of existing cosmetics after completion of an estimated 300' of pipe and concrete for a repair project in the TWA existing restrooms, lobby and meeting space of the facility.

The City of Asheville requires contractor to provide availability of finishes and options prior to installation. Contractor to provide an established timeline of replacement finishes based on inventory. Replacement of Tile floors in both Men's and Women's restrooms, pictured below. Matching existing tile is preferred. If not possible the owner is willing to remove 100% of floor tile and replace it with tile which matches wall tiles and bathroom partitions. Contractor to cover existing mechanical, digital, fire, and electrical prior to repairs. Contractor to have all surfaces cleaned and back in operational condition prior to completion of project. Contractor to have available masking to prevent overflow of debris into additional spaces of the facility. Replacement of Carpet in Meeting Rooms 1 & 2, replacement pieces provided by HCCA house stock. Replacement of wall trim for demoed meeting rooms, commissary and TWA lower lobby. Replaced concrete in TWA lower lobby, commissary, pre function/museum spaces into polished concrete finish.

The start date for repairs is no later than December 11, 2023 with a completion date of no later than January 17, 2024. Contracted work for sewer line replacement and repairs not to exceed \$150,000.00. Contractor to provide all permits and closeout documents.
