

GENERAL CLARIFICATIONS:

1. No bid package was submitted at the initial bid opening on September 14, 2023. A second bid opening is rescheduled for 10:00 AM on Friday, December 15, 2023. The location of the bid opening will be at the South Cary Water Reclamation Facility Conference Room. See Change to the Specifications Section of this Addendum for additional information.
2. Bidders in the process of obtaining a North Carolina Contractors License are eligible to offer proposals on this project. Bidders can use the phrase "To be Provided" when the North Carolina Contractors License information is needed in the submission package. Note it is

required to have North Carolina Contractors License to be awarded for this project. See Changes to the Specifications Section of this Addendum for additional information.

CHANGES TO THE SPECIFICATIONS:

SECTION 00200 – INVITATION TO BID

Page 00200-1:

Replace the first sentence of the first paragraph with the following.

“Sealed bids must be submitted no later than **10:00 am on Friday, December 15, 2023 to the Town of Cary at the Conference Room of the South Cary Water Reclamation Facility**, 4900 West Lake Road, Apex, North Carolina 27539.” Please replace page 00200-1 when the Attachment 1 updated version.

SECTION 00300 – BID PROPOSAL (“Proposal”)

Page 00300-3:

Update the Bid Package submission item 2 to allow bidders in the process of acquiring North Carolina Contractors License to still submit the bid package. Please note that it is required to have North Carolina Contractors License in order to be awarded for this project. The Bid Package submission list is now shown as the following. Please replace page 00300-3 with the Attachment 2 updated version.

- “1. Bid Bond (using forms provided on pages 00300-9 and 00300-10) or other allowable bid security;
2. “9.4. Gas Piping Tests

All gas piping shall be pressure tested according to NFPA 54 – ANSI Z223.1 2024 edition section 8.
The gas pipes are small and short enough to not require specific purging requirements in section 8.3.”

Sealed bids must be submitted no later than **10:00 a.m. on Friday, December 15, 2023 to the Town of Cary at the conference room of the South Cary Water Reclamation Facility**, 4900 W Lake Rd, Apex, NC 27539, Cary, North Carolina. Bids will be opened and read publicly for the furnishing of materials, labor, and equipment for the construction of the South Cary Water Reclamation Facility - Thermal Biosolids Dryer Rotary Drum Replacement, Project No. SW1302. A brief project description is as follows:

Purchase and installation of the Rotary Thermal Drying Drum and Combustion Furnace. Purchase only of the Dual Throat Wet Scrubber.

Where a discrepancy exists between words and numbers in the Bid amount, the written words shall govern. Where a discrepancy exists between unit prices and mathematical computations in the Itemized Proposal, the unit prices and quantities in the Itemized Proposal shall govern.
