	What comprises a complete and working system?	For this project, the new Johnson Systems equipment should be fully installed and set up to work together to control the dimmer racks. Everything required to integrate the new equipment into the existing system should be included in the bid to create a “complete and working system”. If there is existing equipment that is not replaced as part of this bid, and that equipment does not work, it would not be incumbent upon the bidder to fix it to provide a “complete and working system”.																				
	It appears there are conflicting model numbers in the bid.	<div>The model numbers on the riser drawing for the Presidor Wall Stations are correct. 	If Johnson systems will offer a credit for the return of the old modules, how should vendors indicate that?	If there is a credit for the return of the old modules that reduces the cost to the district, vendors should note the amount of that credit in their proposal.
