Pursuant to N.C.G.S. 143-128 and 143-129, sealed proposals endorsed “**Horizons Park Multi-Modal Trails, FB25138**” will be received by City/County Purchasing, City Hall, 101 North Main Street, Winston-Salem, NC until the date and time listed above. Forsyth County reserves the right to reject any or all proposals. Should less than three bids be received, the project will have to be re-advertised.

Bidders must be properly licensed as required by Chapter 87 of the North Carolina General Statutes. A 5% Bid Bond is required at time of bid. 100% Performance & Payment Bonds will be required of the awarded contractor.

This project includes the construction of a multi-modal trail system located at Horizons Park in Germanton, NC. Scope of work and services provided shall be as depicted on the provided drawings/documents, but not limited to: erosion control, grading, surveying, tree removal, trail construction, retaining wall construction, asphalt parking lot construction, site amenities installation, seeding/landscaping/grading.

The M/WBE subcontracting goals for this project are **10% cumulatively**.
