1.0 Introduction

1.1 General: The City of Elizabeth City Electric Utilities Department is seeking to contract qualified Electrical Engineering Consulting firm(s) to provide engineering and planning services. The consultant firm(s) selected for such engineering contract work will provide design and construction oversight work for distribution line modifications and extensions. The consultant firm(s) must also be able to aid in substation work, controls, protection, line conditioning equipment, protective devices, SCADA, AMI, lighting, as well as assisting in day-to-day questions that may require additional professional opinions, etc.

1.3 Contract Length: The firm(s) selected for services will be required to enter into contracts with Elizabeth City's Electric Department for a period of three years. After the end of the three years, the firm(s) selected have the option to renegotiate the contract at that time, and annually thereafter, to continue providing services for up to two additional years.

1.4 Historically Underutilized Businesses: Pursuant to General Statute 143-48 and Executive Order #150, The City of Elizabeth City invites and encourages participation in this procurement process by businesses owned by minorities, women, disabled, disabled business enterprises and non-profit work centers for the blind and severely disabled.

2.0 Scope of Services

2.1 General: The firm(s) will provide a flexible and effective way for the Elizabeth City's Electric Department to execute recurring consultant service needs for multi-dimensional tasks covering a range of electrical engineering objectives.

2.2 Tasks/Projects:

1. Design work for modifications of delivery points if needed. (This work would be dependent upon what may happen at these locations)

2. Modification of protection settings including possible relay testing. For example, the need for modification for adding a hot line tag provision to feeder relays. (Hot line tag modification is a one-time item, but protection settings may need review as system configurations change)

3. Design work for various line extensions within the Elizabeth 's service territory. (This service would be utilized as we build line extensions all over the city).

4. Estimation work for 34kV design work. (This is a large, multi-year conversion project)

5. NCDOT/line-conflict design work. (This work may come at the discretion of the NCDOT at various places and times).

6. Arc Flash and other safety studies. (This work may come as standards making and safety rule making bodies make changes to this evolving suite of standards and rules which may carry significant safety and liability risk).

7. Annual updates to the Five-Year System Plan. (Completed annually, but could require ad hoc updates)

8. Review of SCADA, AMI, OMS, IVR and related systems. (This work could be a variety of things, including advice on consideration of purchase of systems or components from different vendors, how City of Elizabeth City has its system(s) set up and running from a technical or operational perspective, suggestions, or design work to link such systems to other systems.)

9. Answering and providing selection opinions on distribution line and substation construction and maintenance contractors, related electrical equipment, small problem resolution and general technical advice. (Advice from consultant on other contractors, equipment, and general technical advice based on work for other electric systems, their observed best practices, mistakes, etc.)

10. Opinions on the status of City of Elizabeth City's Electric System and means to improve it based on the firm's firsthand knowledge of City of Elizabeth City's system, City of Elizabeth City's design and protection philosophies, City of Elizabeth City's electric system customers, including industrial customers with special needs and unique configurations, special projects, etc. (Completed as a part of other services provided)

11. Review of work done by contractors and other professionals that are included in the other sections of the scope of services. (Completed as a part of finalizing other services provided)

12. Assist in specifications for and solicitations for bids for various major equipment such as power transformers, circuit breakers, reclosers, relays, control circuitry, switches, and the projects listed in this scope of services (Completed as a part of other services provided)

3.0 Adherence to Law

3.1 General: Except as provided below, any firm wishing to be considered must be properly registered with the Office of the Secretary of State and with the North Carolina Board of Examiners for Engineers and Surveyors. Any firm proposing to use corporate subsidiaries or subcontractors must include a statement that these companies are properly registered with the North Carolina Board of Examiners for Engineers and Surveyors.

The Engineers performing the work and responsible for the work must be registered Professional Engineers in the State of North Carolina and must have a good ethical and professional standing. It will be the responsibility of the selected private firm to verify the registration of any corporate subsidiary or subcontractor prior to submitting a Letter of Interest

It is the responsibility of each firm to adhere to all laws of the State of North Carolina. The firm must have the financial ability to undertake the work and assume the liability. The selected firm(s) will be

required to furnish proof of Professional Liability insurance coverage in the minimum amount of \$1,000,000.00.

4.1 General: A qualification-based selection process, administered by the City of Elizabeth City's Electric Department personnel will be used to determine the firm(s) with whom City of Elizabeth City's Electric Department will enter into contracts. These contracts will not address specific projects. Specific projects will be awarded via purchase orders as the city has such needs that are within the Scope of Services.

5.2 Deadline: Letters of interest and qualification must be received by City of Elizabeth City's Electric Department by May 22nd, at 4 P.M. Local Time.

5.3 Minimum Requirements: All submittals should be restrained to the minimum practical length. In no case should they exceed twenty pages. Submittals shall contain the following information:

1. Brief description of firm's proposed project manager(s) and their specific/unique qualifications.

2. Organizational chart indicating all key personnel/sub-consultants to be assigned by discipline (provide names, classifications, and office location).

3. Identify immediate and/or long-term major commitments of project manager and key personnel.

Resumes of all key personnel/ subconsultants (information should be specific to the individual, limited to any relevant/similar work performed during the past five years, and reference unique qualifications).
 Project reference list describing various projects completed within the past five years that represent the strengths and unique qualifications of the firm or team in some or all of the areas identified in Scope of Services section of this document. The list should contain project titles, locations, start and end dates, name of project managers, and name and contact information of references.
