### **BID OPENING**

- Bid opening is <u>Monday, August 12, 2024 at 3:00pm</u> at the office of Charles Oliver at North Carolina Maritime Museum at 315 Front St., Beaufort, NC. All qualified bids received will be opened and publicly read, provided required number of qualified bids are received to open per statute.
- Bids shall be in a sealed envelope with the name of Contractor, Contractor License Number, project name & SCO Project number, date/time of bid opening, on the outside of sealed envelope.
- Requirement to clock-in bid before bid time is called by the Architect, 3:00 p.m. on August 12th.
- No bids will be accepted after bid time is called.

### **COMMUNICATION DURING BIDDING**

- All questions are due no later than **Tuesday**, **July 30**, **2024 at 5:00 PM**. After that date, no questions will be taken. The last Addendum will be sent out on **Friday**, **August 2**, **2024**.



### **USE OF PROPERTY**

- This project will be constructed on an active campus. Sensitivity to the ongoing campus activities and business is to be considered.
- Parking for contractors will be provided during construction.
- Storage and lay down area is to be within the construction area, however, after the award of contract the owner will confirm available laydown space on campus at the Pre-Construction Meeting.
- Work hours are from 7:00 am to 6:00 pm Monday through Friday unless otherwise approved by owner.
- Prior to any demolition the contractor shall document the existing conditions with photographs. The contractor will be held responsible for damage.
- Control dust and debris to adjacent spaces and buildings.
- Noise must be kept minimal or as reasonably achievable.
- Contractor to secure their site. The contractor is responsible for control and accountability of all his tools, equipment and materials of construction.
- Deliveries will be made within certain times and coordinated with the Maritime Heritage Foundation. The owner will not accept or sign for any deliveries meant for the contractor.
- Should temporary closure of any driveway, parking lot, curb and gutter, street, be required for the purposes of construction, the contractor shall document the existing conditions and give the owner no less than 72 hours' notice.
- Do not interrupt utilities serving facilities occupied by the owner unless written permission is received no less than 48 hours in advance of proposed utility interruptions and temporary utility services are arranged.

### **SECURITY AND CONDUCT**

- Security Clearances: All persons entering the NC Maritime Museum Gallants Channel Annex property MUST comply with any required background checks and receive approval for entry.
- Roaming around the NC Maritime Museum Gallants Channel Annex property is not permitted.
- All contractor personnel are expected to observe proper conduct on the job site.
- There will be no tolerance for harassment on the site. Should any contractor, sub-contractor or their personnel be found to have committed harassment, that contractor shall be removed from the site and not allowed to return for the duration of the project. If the individual offender cannot be identified, the entire firm may be removed from the project.
- Any dealings with the media or press while on site shall be approved or otherwise addressed by NCDNCR.
- Smoking is not permitted within 25 feet of a building.
- The Contractor is instructed that no person is permitted to bring firearms, alcoholic beverages of any type, or drugs other than those prescribed by a doctor onto the premises including the parking lots and grounds.
