RAM Promaster 3500 Malley Industries Ambulance

Questions & Answers

1. Your bid document calls out on the first page a "Ram Promaster 3500 Malley ambulance". Malley is a Canadian manufacture of ambulances. Is the school open to alternative ambulances manufactured here in the United States, or must the brand be a "Malley"? I believe that Malley has proprietary territorial dealerships and would only allow for one dealership to bid.

We will entertain any manufacture, but we are looking at the largest size interior we can get due to the fact we have to get a van unit due to costs. If you have a demo you are willing to show us, we are willing to look at. We know the Ram Promaster 3500 has the largest inside area available from what we have been told.

- In reference to item above being a Malley brand ambulance, would the school accept an alternative brand ambulance that is Triple K and CAAS certified that meets the intent of the school, although not exactly the same?
 IE: similar lighting package for emergency lights and similar general layout. Again, yes will compare all aspects of another brand.
- 3. Item spec #1 RPA-A001-002 TEMPERATURE CONTROLLER WITH IMPERIAL UNITS (F). OR EQUIVALENT. Can you please provide more information about this controller? Is this simply a description for the HVAC controls in the ambulance portion of the vehicle or a Temperature control cabinet?

7. Item 15 Action wall C/W digital clock, is this in addition to the analog clock?
