TRAFFIC CONTROL PLAN CLARIFICATION:

The Town is now aligned on their approach to lane and road closures within Town limits. While such closures are common, the Town aims to minimize extended, complete shutdowns on major roads whenever possible. However, the Town understands that closures may occasionally be necessary to complete essential work.

Please note that any planned road closures will require an approved detour plan to ensure effective communication with the public, including schools, public safety, transportation services, and other stakeholders.
