Clayton Arbors Lift Station Diversion

Bid No. 700-ENG-2024-03 - This is a re-advertisement for Bid 700-ENG-2023-18

Bids for the construction of the Project will be received at the **Town of Clayton Town Hall** located at **111 E. Second St. Clayton, NC 27520** until **2:00 PM local time on Tuesday, September 19, 2023**. At that time, the Bids received will be publicly opened and read in the Council Chambers.

The Project includes the following Work:

The project consists of the construction of approximately 250 LF of 8-inch gravity sewer to divert flow from the existing Arbors Lift Station to the existing 24-inch Little Creek WRF Transmission Gravity Sewer (MH GS-42). In addition, the Arbors Lift Station is to be decommissioned. As part of the decommission, an alternate bid is to be received to relocate an existing above ground Dri-Prime pumping unit and propane fuel tank from the Arbors Lift Station and install both at the Town's Walnut Creek Lift Station, along with associated site revisions.

Bids are requested for the following Contract: **Clayton Arbors Lift Station Diversion/ Bid No. 700-ENG-2024-03.**

The Project has an expected duration of **210** days.
