

INVITATION TO BID

Sealed proposals will be received in the **Cumberland County Schools' Operations Center Plans Room, 810 Gillespie Street, Fayetteville, NC 28306**, until **Thursday, February 20th, 2025, at 11:00am**. At which time they will be publicly opened and read aloud for the **Armstrong Elementary School Cafeteria/Media Center Roofing Project**. The general scope of work will consist of the overlay of the existing Cafeteria/Media Center roof with 1/2" adhered cover board and single ply adhered membrane material.

Single prime proposals only will be received for all construction work. The Owner encourages participation by minority businesses. Complete Bid Documents will be issued electronically to all interested and qualified bidders. A **Mandatory Pre-Bid Conference** will be held at the site. Contractors interested in bidding shall meet at **10:00am on Thursday, February 6th, 2025**, at Armstrong Elementary School, **3395 Dunn Road, Eastover, NC 28312**, (910) 483-2425.

Requirements for bidding this project are as follows:

1. Three references from previously satisfied public-school customers of similar size, scope & timeframe.
2. **Furnish NC License Number** (G.S. Chapter 87 establishes licensing requirements for general, plumbing, heating, electrical, and refrigeration contractors for construction projects costing \$30,000 or more).
3. Insurance - The Contractor shall provide, as required by law, insurance for his employees. The Cumberland County Schools assumes no liability for injuries or accidents related to the Contractual Agreement. The Contractor shall furnish a certificate to the Owner (Cumberland County Schools) as a Proof of Coverage. The Contractor shall maintain and pay the Insurance Coverage, which shall not be less than the following:
