The following changes and clarifications are applicable to the referenced project and are now a part of its contract documents. Where any article, division, or subparagraph of the original contract documents or other addenda is supplemented herein, the provisions of the original documents shall remain in effect. All the supplemental provisions shall be considered as added thereto. Where any such article, division, or subparagraphs are amended, voided, or superseded thereby, the provisions of such article, division, or subparagraph not so specifically amended, voided, or superseded shall remain in effect.

The attention of each contractor is called to the following clarifications, additions to, and changes in the plans sealed January 02, 2024, and specifications and contract documents sealed on January 17, 2024, for the above project. It will be the responsibility of each contractor to call such clarifications, additions, and changes in plans and specifications to the attention of subcontractors concerned. The City in no way assumes any responsibility for notifying any subcontractor, material dealers, or others not having received the original contract documents.

Item 1: Revised Plans for FY23 Traffic Calming Project:

Mackinac Island Plan has been updated to show 2 signs added on sheet #24. Sierra Dr Plan has been updated to show 26 sharrows added on the Plan.

Item 2: Revised Bid items for FY23 Traffic Calming Project:

- Thermoplastic Pavement Bicycle Symbol (90 MILS) Sharrows: 251 Each.
- Contractor Furnished Sign (Per location): 169 Each

Item 3: Questions / Comments received, and Answered:

Question: Are there sharrows or speed hump ahead signs to be installed on Peterson Street? **Answer:** Signs exist in the field, no addition signing necessary. There are temporary bolt down

speed cushions along Peterson St. - Sharrows are not being added.

Question: It seems that on some of the roads there doesn't appear to have speed hump warning signs on both sides of the speed hump. Here are the streets we find that fall into this category. On Dixie Trail possibly 2 speed hump ahead signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed.

Question: Slippery Elm Dr Possibly 4 speed hump ahead signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed Question: On Wild Wood Way one of the four entrances to the round a bout are missing markings

Answer: Eastbound entrance to traffic circle is a private street and not public right-of-way, no marking requirement

Question: On Quail Ridge Road possibly 8 Speed Hump Ahead signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: On Mackinac Island Lane possibly 6 Speed Hump Ahead Signs are missing

Answer: 2 speed hump with ahead advisory plaque signs are missing on page 24 and will be added on the plan.

Question: On Mine Shaft Rd possibly 4 Speed Hump Ahead Signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: On Willow Oak Rd possibly 2 speed hump ahead signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: On Dixon Dr Possibly 4 Speed Hump Ahead Signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: On Country Trail possibly 4 speed hump signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: On Thorpshire possibly 6 Speed Hump Signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: On Jacqueline Lane Possibly 6 speed hump ahead signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: On Bertie Drive possibly 6 Speed Hump Ahead Signs are missing

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: and on White Oak Road Possibly 10 Speed Hump Ahead Signs are missing.

Answer: All stretches appear to be marked; no additional signs identified as being needed

Question: Here are some street locations that may need sharrows and/or bike lanes according to the shared lane spec we find in the drawings.

Thorpshire is about 38' wide and does not have existing bike lanes or sharrows on the road from google earth.

Answer: Sharrows/Bike Lanes are not being proposed on this street

Question: Sierra Dr is about 38 ' wide and does not have existing bike lanes or sharrows on the road from google earth

Answer: 26 sharrow markings are missing on this street and will be added on the plan. **Question**: Dixon Dr is about 33' across the road and does not have existing bike lanes or sharrows on the road from google earth

Answer: Sharrows/Bike Lanes are not being proposed on this street

Question: Mine Shaft Rd is about 35' wide and does not have existing bike lanes or sharrows on the road from google earth

Answer: Sharrows/Bike Lanes are not being proposed on this street

Question: Wild Wood Forest Dr is about 36' wide and does not have existing bike lanes or sharrows on the road from google earth

Answer: Sharrows/Bike Lanes are not being proposed on this street

Question: and Slippery Elm Dr is about 36' wide and does not have existing bike lanes or sharrows on the road from google earth.

Answer: Sharrows/Bike Lanes are not being proposed on this street

Question: Historically there have been damage to signs during construction including theft, vandalism, and vehicular negligence. Can you please clarify the contractor and City responsibility as to replacement of damaged signs that are out of the contractor's control?

Answer: It is the contractor's responsibility to protect the work until the City has accepted the project.

Question: If the contractor cannot be compensated for replacement until the project is completed, would the City consider inspection and approval for each roadway separately as they are completed?

Answer: The City will issue one acceptance letter for the project. Each roadway will not be accepted separately.
