RFP EMS FY25-011 Comfort Shelters

This addendum is being issued to provide clarification to specifications of the bid following questions from potential bidders. The Proposer must acknowledge receipt of this addendum (Attachment A) for the Proposal to be deemed acceptable. No consideration will be allowed due to any potential Proposer not being aware of or familiar with this addendum. This addendum shall form part of the RFP and is to be read, interpreted, and coordinated with all other parts.

What specific personnel are needed?

Personnel for operations of sheltering such as logistics, mobilization, demob, support. Not running shelter evacuees

How many shelters should personnel be planned for?

This would depend on disaster level, these can be grouped (i.e. 1-3, 4-6)

Where will the shelters be located?

Disaster dependent.

What type of structure will shelter be (i.e. Tent, brick and mortar, etc.)?

Tent, Western Shelter

How many personnel for each position are needed?

Monitoring of supplied shelter, mobilization, demobilization

Will "Comfort Shelters" be opened "pre" or "post" landfall? Post

What is the shelter capacity (i.e. 50, 100, 1000, etc.) to plan staffing for? 50-100

Will meals be provided at shelter? If yes, who is responsible for this task?

If yes, who is responsible for this task. Not by contractor

Will shelter personnel have meals available to them at the shelter or will contractor be responsible for providing meals to personnel?

Yes, provided for staff.

Will shelter personnel have designated sleeping quarters on-site at shelters or will contractor be responsible for providing lodging for personnel?

Sleeping on-site, rooms provided by contractor

What level of background screening is required for personnel? Background check

What specific personnel to support Shower/Restroom Trailers and Washer/Dryer Trailers?

Support for logistics, mobilizations, demobilizations, support.

How many personnel to support Shower/Restroom Trailers and Washer/Dryer Trailers? Same as above

Standby Costs - Will standby costs be paid weekly from time contract is awarded through Nov 30, or will Subs be paid a lump sum to have a specific number of personnel on standby for this contract?

These will be paid starting activation from disaster.

Vendor must be capable of mobilizing within [Insert Required Timeframe, e.g., 24–48 hours] upon request from Beaufort County Emergency Management.

Will the County please provide the expected mobilization timeframe? Or acknowledge future timelines will be determined at the task-order level based on the event and needs of the County?

The expected mobilization timeline is 24-48 hours upon activation.

Could you please confirm whether Beaufort County will provide a pricing sheet or template that lists the required asset line items for each RFP?

Can the Owner provide any further insight and information on how it wants this project to be quoted, and more specifics on what exactly it wants priced?

This will be the pricing for comfort shelters, laundry services w/ water, shower trailers with water. This can be priced in groups(ex. 2-4, 4-8 w/ staffing) also this can be applied to the fee schedule.

Will this contract be used only for hurricane prep? And is the period of performance only during the June 1 – November 30th time frame?

This will be for any disaster that Beaufort County may encounter. Terms are listed in the Terms portion of the RFP.

Will the contracting party do an amendment to the contract for winterization on the bladders/ tanks or does the all-in cost need to reflect this?

The cost should be reflected. In Beaufort County we are more susceptible to Hurricanes than winter weather.

As for the Comfort Shelters, do you have any more information on what is being requested?

- Is this just for tents or are you wanting pricing for like sleeper trailers? Western Shelters, Tents, etc.
- What size Tent structures are you looking for us to provide and price? Our county is vast in landscape, these sizes could vary. So options could be included in the FEE Schedule.
- What are the expected uses of the tent structures? (living quarters, cafeteria, etc?) Possible.
- Flooring requested? This can be an option.

Please confirm what is meant when it says vendors are responsible for "operation of temporary shelter facilities"? Providing labor for facilities. Beaufort County will provide sheltering staffing.

Please confirm whether the Owner will be "operating" and overseeing the actual evacuee facilities. Please see above.

Do you have any sort of pricing sheet for vendors to use so that Owner receives an apples to apples comparable quote from the various vendors. No.

To follow the ICS guidelines pertaining to Command, Operations, Planning, Logistics, and Finance. This will fall under the logistics branch.

Insurance & Compliance

Compliance with FEMA reimbursement requirements and procurement guidelines

With the County anticipating partial or full FEMA reimbursement for work performed under a resultant contract from the above reference RFP, we respectfully request the RFP be amended to add the applicable Service Contract Act Wage Determination as well as ALL applicable federal acquisition clauses.

This will follow all FEMA guidelines, 44 CFR Part 206, 44 CFR Part 207. These are outlined in the 2 CFR 200 uniform guidance.

Response Time & Activation

Vendor must maintain availability during hurricane season (June 1 – November 30) and provide standby capabilities upon notice of a pending disaster.

-Please clarify, is the County requiring dedicated assets for pending disasters?

These are pre-positioning contracts. These are put into place before a disaster, dedicating services to Beaufort County, NC. These are not active until the activation of the resources needed.
