

## INVITATION TO BID

Sealed proposals will be received **2:00 p.m. May 29, 2025**, in the Cumberland County Schools' Operations Center Plans Room, located at 810 Gillespie Street, Fayetteville, NC, at which time they will be publicly opened and read aloud for the **Nick Jerald's Middle School Walk-in Cooler / Freezer Remodel**.

*This work will include the removal of an existing combo cooler / freezer to be replaced with a new combo / freezer in the Kitchen. A new freezer will be installed in the Receiving Area that will involve the removal of the ceiling of the entire area. A new power feed from an existing electrical panel. A new ceiling in the Kitchen and Serving Lines will be installed with new light fixtures. Fresh painting of the Receiving Area will be required.*

**A Mandatory Pre-Bid Conference** will be held at **11:00 a.m. on May 16, 2025**. Contractors interested in bidding shall meet Nick Jerald's Middle School (Main Office), 2517 Ramsey Street Fayetteville, NC 28301 (910) 822-2570. **Complete Bid Documents will be issued once requested via email** from Richard Grice, Project Manager, Cumberland County Schools, (910-446-3289) [richardgrice@ccs.k12.nc.us](mailto:richardgrice@ccs.k12.nc.us). No plan deposit; Bid Bond, Performance and Payment Bonds will be required for this project.

Single prime proposals only will be received for all construction work. The Owner encourages participation by minority businesses.

Requirements for bidding this project are as follows:

1. Three references from previously satisfied commercial customers.
2. **Furnish NC License Number** (G.S. Chapter 87 establishes licensing requirements for general, plumbing, heating, electrical, and refrigeration contractors for construction projects costing \$30,000 or more).
3. Insurance - The Contractor shall provide, as required by law, insurance for his employees. The Cumberland County Schools assumes no liability for injuries or accidents related to the Contractual Agreement. The Contractor shall furnish a certificate to the Owner (Cumberland County Schools) as a Proof of Coverage. The Contractor shall maintain and pay the Insurance Coverage, which shall not be less than the following:
