- 1) Roof Areas A, B, C and E (Re-Cover):
 - a. Removal of lightning protection system and storage for reuse.
 - b. Removal and disposal of all existing metal flashings, scupper liners and coping caps; installation of new polyisocyanurate roof insulation, gypsum cover board and overlay, fleeceback Polyvinyl-Chloride (PVC) roof membrane and flashings, wood blocking, metal flashings, coping caps, PVC scupper liners and all associated miscellaneous work as specified herein.
 - c. Removal of existing brick along wall above roof level at Area D as necessary; and installation of new through-wall flashing and brick replacement consisting of use of salvaged brick if in good condition and providing new brick (to match existing) as required. d. Reinstallation of lightning protection system upon completion of the roofing work according to specifications and requirements of the original UL master label installation.

This Contract is subject to the requirements of 49 C.F.R. Part 26, Participation by Disadvantaged Business Enterprises in DOT Financial Assistance Programs and the City's DBE Program. The DBE Program is incorporated into and made a part of the Bidding Documents and resulting Contract. Pursuant to 49 C.F.R. Part 26 and the DBE Program, all Bidders must affirmatively ensure that in any contract entered into with the City, DBEs will be afforded equal opportunity to participate in subcontracting opportunities.

A contract goal of **4.0%** DBE participation has been established for this Contract.

A Bid will not be considered responsive unless the Bidder complies with 49 C.F.R. Part 26 and the City's DBE Program. Using the List of Subcontractors/Suppliers – FORM A provided in Section 00 40 00 of this Project Manual, Bidders are required to submit with their Bid, in accordance with federal law and the DBE Program Requirements, the names, addresses, contact information, how long each subcontractor has been in business (age of firm), annual gross receipts, respective scopes of Work to be performed, NAICS Code, NCDOT Reporting Number, the dollar values of each subcontract that the Bidder proposes for participation in the Contract Work, and the dollar value of total DBE participation for the Contract. The purpose of this information is to facilitate the evaluation of proposed subcontractors' technical ability. Buy America

Buy America requires all iron, steel and manufactured products used in the Project to be produced in the United States.

As a matter of Bid responsiveness, Bidders must indicate in their Bid how they intend to comply with Buy America requirements. Bidders must complete and sign whichever of the two (2) certificates is applicable; **under no circumstance should both certificates be submitted.** The certificate must be signed by the person signing the Bid Form and submitted with the Bid. The certificate cannot be submitted after Bids have been opened. The certificate shall become part of the Contract Documents. See Section 00 40 00 of this Project Manual for the certifications.

A Bidder who has submitted an incomplete Buy America certificate or an incorrect certificate of non-compliance through an inadvertent or clerical error (but not including failure to sign the certificate, submission of certificates of

both compliance and non-compliance, or failure to submit any certification), may submit to the FTA Chief Counsel and CATS General Counsel within ten (10) calendar days of bid opening a written explanation of the circumstances surrounding the submission of the incomplete or incorrect certification in accordance with 28 U.S.C. 1746, sworn under penalty of perjury, stating that the submission resulted from inadvertent or clerical error.

Failure to comply with Buy America requirements, in addition to other remedies available to the City, will result in the Contractor removing the non-compliant product and replacing it with a Buy America compliant product at the sole cost and expense of the Contractor, as well as any other costs associated with replacement.

It is imperative that Bidders read and understand all requirements relating to Buy America as stated here and in Article 1.3 Buy America of Section 00 55 00 of this Project Manual.
