Pursuant to North Carolina General Statute 143-131, bids will be received by the City of Asheville Harrah's Cherokee Center Asheville at 87 Haywood Street, Asheville, NC 28801, until August 16, 2024, 4:00pm, for the project described as follows:

Description of Work:

Install a multi head mini split heat pump in the Harrah's Cherokee Center Asheville Operations break room and office space. Contractor will supply all the necessary equipment, material and make arrangements with any subcontractor to complete the project.HCCA staff will provide the contractor information about the location of the electrical panel that can be used and general idea for placement of the equipment for the project. Contactor is to supply one Daikin model number 3MXS24WMVJU9 mini split multi zone heat pump, two Daikin indoor high wall wall heads, one model numberFTX09WVJU9 and one FTXS18WVJU9, or equal or greater than specified equipment. Contractor will be responsible for all permits for the project. The contractor and/or subcontractor will provide a consistent project manager to be present when their staff is working during the project time frame.

Standard of Award:

The award of the Contract will be made to the lowest responsible, responsive bidder, who, in the opinion of the City, is qualified to perform the work required and is responsible and reliable. When Alternate Bid items are required in the Bid, the Contract will be awarded to that responsible Bidder whose Bid for the Alternate or combination of Alternates, selected by the City, is the lowest.

• Asheville Business Inclusion Policy: The City of Asheville has adopted the Asheville Business Inclusion Policy to encourage women and minority businesses' participation in the public bidding process. The purpose of this outreach effort is to increase the likelihood of availability and utilization of MWBEs in the award of contracts. Drug Free Workplace: The City of Asheville is a drug-free workplace employer. By submitting this bid, the prospective contractor certifies that if awarded the contract, they and their subcontractors shall comply with the following:

The City requires contractors/vendors entering into a contract with the City to provide a drug-free workplace in the performance of said contract. The contractor, upon execution of the contract, certifies that it will provide a drug-free workplace during the performance of the work on this contract. The contractor agrees to do the following:

Notify employees that the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance is prohibited in the workplace and specify the actions that will be taken for violations of such prohibitions. Responsive actions should be appropriate and sufficient to address and remediate any violations of this requirement.

Payment of Taxes:

Bid proposals shall include the cost of required insurance and bonds and payment of any applicable local, State and Federal taxes. The City Council of the City of Asheville has adopted a policy that the City of Asheville will not enter into contracts with bidders who are delinquent in the payment of ad valorem taxes owed to the City of Asheville.

License Requirements:

All bidders must have current North Carolina HVAC licenses with the appropriate classification for all work of the project at the time of the bid. The contractor or sub-contractor must have all appropriate licenses as required. +

Bid Submittals:

The City has prepared this Advertisement for Bids which identifies the services to be undertaken.

In order to be considered, all bids must be submitted in writing no later than the bid due date. Contractors mailing bid packages should allow delivery time to ensure timely receipt of their bid. The responsibility for getting their bid to the City of Asheville on or before the specified time and date is solely and strictly the responsibility of the proposing contractor. The City will in no way be responsible for delays caused by any occurrence.

- All bids must be submitted on the form of Bid Proposal provided.
- The successful bidder will be required to furnish a performance bond and a payment bond in the amount of one hundred percent (100%) of the contract amount for contracts costing more than \$50,000 that are part of a project costing more than \$300,000. Those bonds shall meet the requirements of North Carolina General Statutes Section 143-129 and of Article 3 of Chapter 44A of the North Carolina General Statutes.
