Any Statement of Qualifications received after that time will not be considered.

I. Project

The Yadkin County Board of Education ("Board of Education") seeks CM@R services for renovations to the gymnasiums at Forbush High School and Starmount High School. See item VI of this RFQ for a description of the project.

II. Professional Services Required

The Board of Education seeks CM@R services with full-service pre-construction and construction services.

III. Schedule

Interested parties are to submit responses to this RFQ not later than 3:00 p.m. EDT on Wednesday, August 21, 2024. The Board of Education plans to select a CM@R firm for this project not later than September 9, 2024.

IV. Selection Criteria and Format of Proposal

The following criteria will be used in evaluating each Statement of Qualifications submitted in response to this RFQ. Please provide (12) copies of your submittal.

- A. Give corporate history of the company including organizational structure, years in business, and evidence of authority to conduct business in North Carolina.
- B. Please identify the projects during the last five (5) years in which you served as CM@R. Provide name, location, and total dollar value for each project.
- C. Please identify the projects upon which you are currently committed. Provide name, location, commencement date, substantial completion date, and total dollar value for each project.
- D. Please attach a letter from a surety company (or its agent) licensed in North Carolina verifying your ability to provide adequate performance and payment bonds for this project.
- E. Please identify all construction projects for public school districts or other governmental agencies in North Carolina in which you have been engaged during the last five (5) years. Provide name, location, and total dollar value for each project.

VI. Project Description

The project base bid consists of two auxiliary gymnasiums' approximately 11,600 square feet with locker rooms, concessions and group toilets. Construction will be poured in place concrete floor slab, metal studs and brick exterior walls, CMU corridors, metal building frame & roofing.
