Pursuant to the City of Asheville's Procurement, Purchasing and Contracting Policy, Bids will be received by the City of Asheville for the following:

Description of Work:

Provide monthly or quarterly interior and exterior insect pest control and rodent control services at various locations.

Scope of Work:Insect Control

Interior -

- Monthly inspections on and treatment for common areas including :
 - o Restrooms, break areas, vending areas, kitchens, and dining areas
- Office will be inspected and treated as needed upon request

Exterior -

• Perimeter spot treatment will be done monthly as needed, at ground level up to six (6) feet out from the structure to control crawling insects.

Rodent Control

Interior -

• Vendor recommended stations in highly vulnerable areas inside the structure. Stations will be cleaned.

inspected and serviced monthly and replaced quarterly or more frequently if needed.

Exterior -

• Vendor recommended tamper resistant bait stations will be placed in strategic locations around the buildings. Stations are to be cleaned, inspected, and serviced monthly. Bait to be replaced as needed.

Asheville Business Inclusion Policy: The City of Asheville has adopted the Asheville Business Inclusion Policy to encourage women and minority businesses' participation in the public bidding process. The purpose of this outreach effort is to increase the likelihood of availability and utilization of MWBEs in the award of contracts. It is the Policy of the City to (1) provide minorities and women an equal opportunity to participate in all aspects of its contracting and procurement programs and (2) to prohibit any and all discrimination against persons or businesses in pursuit of these opportunities.

General Services: A 2023 disparity study conducted by the City of Asheville indicated a disparity among Minority-and Women-owned businesses (MWBEs) on general services contracts. The study indicated that of the contractors available for utilization on general services, 8.39% are Black or African-American-owned and Women-owned. The City of Asheville has set an annual aspirational MWBE goal of 8.39% for general services contracts. Although achieving this goal is not a criterion for the award of this Contract, it is expected that documents will reflect that every effort has been made to conduct inclusive outreach to ensure that contractors with existing disparities have an opportunity to participate in contracting with the City of Asheville.

The Bidder shall provide applicable ABI Affidavits, as described in the project manual on page 17 - Asheville Business Inclusion (ABI Goals), with their bid in order to be deemed responsive, failure to do so will result in the Bidders bid being deemed non-responsive and disqualified.

Drug Free Workplace: The City of Asheville is a drug-free workplace employer. By submitting this bid, the prospective contractor certifies that if awarded the contract, they and their subcontractors shall comply with the following:

The City requires contractors/vendors entering into a contract with the City to provide a drug-free workplace in the performance of said contract. The contractor, upon execution of the contract, certifies that it will provide a drug-free workplace during the performance of the work on this contract. The contractor agrees to do the following:

Notify employees that the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance is prohibited in the workplace and specify the actions that will be taken for violations of such prohibitions. Responsive actions should be appropriate and sufficient to address and remediate any violations of this requirement.
