Description of Bid:

In the aftermath of Tropical Storm Helene, the establishment of secure debris sites was imperative to ensure public safety. The City of Asheville is seeking professional security cameras at multiple locations, and continual service to uphold the safety and integrity of the debris management operation. The needs of the city are as follows:

- Must have at least six units available with a potential of 6 additional units in the future.*See specifications on page 7
- Registration tags will be issued by the City of Asheville.
- We are requiring the vendor to be fully licensed to perform all aspects of the job.
