# B. Minority Business Plan

# C. Drug-Free Workplace

The City of Asheville is a Drug-Free Workplace Employer. By submitting this bid, the Prospective Contractor certifies that if awarded the Contract, they and their subcontractors shall provide a drug-free workplace during the performance of the contract; and shall notify employees that the unlawful manufacture, distribution, dispensation, possession or use of a controlled substance is prohibited in the workplace, and shall specify the actions that will be taken for violations of such prohibitions. Responsive actions should be appropriate and sufficient to address and remediate any violations of this requirement.

# D. Bid Bond

#### PM Note:

• The City of Asheville Bid Bond form is included under Addendum #01. <u>Bidders can also utilize their own form.</u>

All bidders are required to submit cash, a cashier's check, or certified check in an amount equal to five percent (5%) of the bid proposal. In lieu of said money, the bidder can submit a Bid Bond (please use the City's Bid Bond Form provided in the Bid Documents) executed by a corporate surety licensed in North Carolina to execute said bonds. This deposit shall be retained if the lowest responsible bidder fails to execute the contract within ten (10) days of the award or fails to give satisfactory surety as required in North Carolina General Statutes Section 143-129.

• All bids and bid bonds shall be sealed in two (2) separate envelopes and shall not be opened prior to the time set for the bid opening.

### E. Payment/Performance Bonds

The successful bidder will be required to furnish a Performance Bond and a Payment Bond in the amount equal to 100% of the contract amount. Those bonds shall meet the requirements of North Carolina General Statutes Section 143-129 and of Article 3 of Chapter 44A of the North Carolina General Statutes. Please use the City's Bond templates found in the Bid Documents.

#### F. Bid Submission

# A. Sealed bids are due Thursday, February 27th @ 3:00pm.

- Your two sealed envelopes (one with your bid and the other with your bid bond/cash/cashier's check/ certified check) should be delivered to the Security Guard Station at 70 Court Plaza, Asheville, NC 28801
- Each envelope must be labeled glued or taped shut and labeled with the Bidders Name, Bid Number and the Project Name
- Bids will be opened and read in the Purchasing office. The bid opening can be attended in person or virtually via the GoogleMeet link posted on the City's bid page at ashevillenc.gov/bids

# IV. Contract Section 2: General Requirements

- A. Scope of Work
  - The project includes the construction of concrete sidewalk, drive aprons, utilities

- adjustment, pavement markings, grading, and landscaping.
- Contract Section 4: Supplemental Information (supplemental to Final Design plans)
- The Contractor shall begin work upon notification to proceed by the City, and shall complete the work within 240 calendar days thereafter, unless said time period is extended by written consent of the City through its authorized representative.
- Liquidated Damages related to failure to achieve Substantial Completion in time will be charged at **\$500** per working day.
- Utilities to be located prior to beginning the project
- Construction Staging / Access and Traffic Control to be determined by Contractor
- Materials Testing: to be performed by separate contractor
- Permitting: none required

# V. Contract Section 3: Special Requirements/Provisions

- A. Certified Stormwater Supervisor, Foreman, and Installer required.
- B. Day and Time Restrictions
  - Construction will be during daylight hours only (7 A.M. to 7 P.M.). Work days are Monday through Friday. If the contractor wishes to work on Saturday prior approval shall be obtained from the Project Manager. There will be no work on Sunday. Certain parcel owners within the project extents may have time restrictions on work within the parcel, and these restrictions will be discussed prior to the project start. However, all work within 5 feet of the roadway requires temporary lane closures during night hours (7 PM 6 AM). It's expected that all curb and gutter removal, installation, saw cutting, asphalt repair, etc., will need to occur at night, per NCDOT requirements.
- C. Intermediate Contract Time + Liquidated Damages
  - The Contractor shall not narrow or close a lane to traffic during daytime hours for any reason except for the delivery and placement of concrete. The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic for the purpose of delivery and placement of concrete on US 19/23 (Patton Ave) during the following time restrictions unless approved by the Engineer:

DAY AND TIME RESTRICTIONS 6:30 AM to 9:00 AM and 3:00 PM to 6:30 PM (EVERY DAY)

The time of availability for this intermediate contract time will be the time the Contractor begins to install traffic control devices required for the lane closures according to the time restrictions stated herein.

The completion time for this intermediate contract time will be the time the Contractor is required to complete the removal of traffic control devices required for the lane closures according to the time restrictions stated herein and restore

traffic to the existing traffic pattern.

The liquidated damages are Six Hundred Dollars (\$600.00) per half hour.
