		that calculates the final contract	
		price. There is not a place to	
		enter an actual final price to the	
		State or a place to offer a line by	
		line discount for each item.	
		Having one minimum discount %	
		off list severely restricts the	
		ability to offer different better	
		pricing across the wide spectrum	
		of manufacturers and products	
		that is represented by 311 items.	
		For example, for some products	
		we may be able to offer a 5%	
		discount, and others we can offer	
		a 50% discount. Given the	
		structure of this worksheet, we'd	
		only be able to enter 5% and the	
		State would lose out on any	
		discounts above the 5%. Also List	
		Prices may vary across bidders, so	
		a 10% off one bidder's list could	
		be equivalent to a 20% discount	
		off a different bidder's list price.	
		It would not allow for accurate	
		comparison between	
		participating bidders.	
		Without a change in the	
		worksheet, it would result in a bid	
		that does not reflect bidder's	
		ultimate intended prices to the	
		state.
